Background

The California Public Utilities Commission (CPUC) launched the Policy+Innovation Coordination Group for the Electric Program Investment Charge (EPIC) to gather insights and lessons learned from EPIC electricity research, development & deployment projects in the State, and to identify new opportunities for collaboration to accelerate innovation. The Policy+Innovation Coordination Group is facilitating four workstreams for 2020: equity, transportation electrification, wildfire mitigation, and public safety power shutoffs.

<u>Wildfire Mitigation Workstream</u>: The goal of the Wildfire Mitigation workstream is to gain insight for policy makers assessing investment decisions around wildfire mitigation. The workstream will conduct three meetings between September and December 2020. Wildfire Mitigation Meeting 2 will focus on Presentations by utility EPIC projects, Wildfire Mitigation Plan Pilots, or other RD&D on situational awareness, sensing, predictive maintenance and other technology solutions.

Presenters will address some, or all, of the following core questions:

- How can we evaluate the cost benefit of the status quo versus new technical upgrades?
- How can we decide what technology or strategy is most effective from a location and cost perspective?
- What specific technologies or asset management strategies can measurably reduce the risk of a fault becoming an ignition?
